making must exploit the potential for positive side effects and control the negative side effects of managerial decisions the theory of ethical economy analyses the principles of just price and fair pricing and the relevance of the theory of just price for the pricing behaviour of the modern firm principles of ethical economy forms a theoretical synthesis of the market theory of modern economics and of the natural right tradition of ethics it creates new insights into the ethics of the market as well as in the economics presuppositions and consequences of ethical duties virtues and goods
