2 Static Analysis Static analysis tools automatically examine the source code and design documents to identify potential architectural flaws such as circular dependencies or violations of design rules

Dynamic Analysis This involves running the system under controlled conditions to measure its performance and identify bottlenecks Profiling tools and performance monitoring systems are commonly used
